Re: Maggie's at the Royal Free Hospital – Application for Discharge of Planning Condition in relation to Full Planning Permission (Ref. 2019/4937/P).

On behalf of our client, Maggie's Trading Ltd, we hereby submit an application to discharge Condition 3 of Planning Permission (2019/4937/P), decision dated 22nd January 2021. This submission specifically seeks to discharge the detail required for Condition 3.

Full Planning Permission was granted consent on 22nd January 2021 for the following:

"Erection of new building to provide a Maggie's Centre (435sqm net floorspace) non-residential institution (ancillary to Royal Free) - and associated landscaping works.
