## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Work -

Fell and removal of stumps for 3 Beech Trees T7, T8, T9 and Fell and treat stump T10.

Reasons -

There is appropriate arboricultural justification for the tree's removal due to the restricted rooting environment, historical, current and potential damage to adjacent walls. The low public amenity they provide does not justify the expense of addressing the damage, with an engineered solution. A long-term cost-effective solution for the retention of the trees is also difficult to achieve when considering the species' future growth, the site constraints and level differences.

Appropriate mitigation is proposed with replacement planting to provide and maintain canopy cover on the property. Tree species and positions will be varied to provide more appropriate species closer to the building, or positions more suited that will allow replacements to grow to maturity.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
