The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans-Site Location Plan 331 PL 401, 331 PL 402, 331 PL 405, 331 PL 505, 331 PL 417, 331 PL 409, 331 PL 509, 331 PL 517, Design and Access Statement Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policies D1 and D2 of the London Borough of Camden Local Plan 2017.

Informative(s):

1 Reasons for granting permission.

The proposed window would be located on the north side elevation of the property and would appear as a minor addition that would not detract from the appearance of the host building or the streetscene. The window would be timber framed which is considered a traditional material and is acceptable in the conservation area.

The window would face onto neighbouring no. 1a Frognal Gardens, which is a single storey building. The window would therefore look out onto the roof on the neighbour with no direct views into any sensitive windows. The proposal is not considered to cause any adverse impacts on the amenity of adjoining residential occupiers in terms of overlooking or light spill.

The proposal is considered to preserve the character and appearance of the host building and conservation area. Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the Conservation Area, under s.72 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended by the Enterprise and Regulatory Reform Act 2013.

No objections have been received prior to making this decision. The planning history of the site has been taken into account when coming to this decision.

As such, the proposed development is in general accordance with policies A1, D1 and D2 of the Camden Local Plan 2017 and policies DH1 and DH2 of the Hampstead Neighbourhood Plan 2018. The proposed development also accords with the London Plan 2021 and the National Planning Policy Framework 2021.

Noise from demolition and construction works is subject to control under the Control of Pollution Act 1974. You must secure the approval of the Council's Noise and Licensing Enforcement Team prior to undertaking such activities outside these hours.
