T153 - Liriodendron tulipifera (Tulip Tree):

PRA - Prune back adjacent competition - NEIGHBOURING Cotoneaster - reduce height by 4m & spread by 1-2m to provide minimum 1m clearance from tulip tree, to allow more light through.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
