T1 Lime tree -rear garden Crown thin by 30%. Reduce height by 2.5m. Reduce lateral growth by 1.5m. A repeat of maintenance pruning, some 3-4 years ago The tree overhangs several gardens, where excessive shading is an ongoing issue We have endeavoured to resolve this requirement over the past 25 years (at least) without resorting to brutal treatment, as in adjacent properties, where crude pollarding has been carried out.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
