Reduce back garden limes (T1 & T2) back to previous most recent cuts (2-3m) whilst leaving furnishing growth to allow more light into garden.
Fell dead, front garden cherry tree (T3), leaving a 1.5m stump. This will prevent dead branches falling onto passing pedestrians.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
