- 1 Lewis Cubitt Park (Lawn) Formal prune 15 x Plane trees to mirror image each other. Crown Lift to 5m and clear street lamps. Pages 9 & 10 on survey location map, tree ref: 252, 253, 254, 255, 259, 260, 261, 262, 263, 264, 265, 269, 270, 271 & 272
- 2 Lewis Cubitt Park (Lawn) 2 groups of 3 x Lime trees, crown lift to 3.5m to allow light in. Pages 9 & 10 on attached survey location map, tree ref: 256, 257, 258, 266, 267 & 268
- 3 Lewis Cubitt Park (Lawn) 2 x Red Oaks, formal prune into 1 tree shape for both. Reduce outward laterals. Pages 9 & 10 on attached survey location map, tree ref: 218, 219, 244, 245, 247 & 250
- 4 Handyside Pollard 2 x Plane trees as these trees have been left unmaintained, resulting in growth points that are not strong enough causing issues. Page 13 on attached survey location map, tree ref: 338 & 339
- 5 Lewis Cubitt Square 11 x London Plane trees, formal prune and crown lift to 3m. Remove any deadwood. Page 7 on attached survey location map, tree ref: 142 152

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
