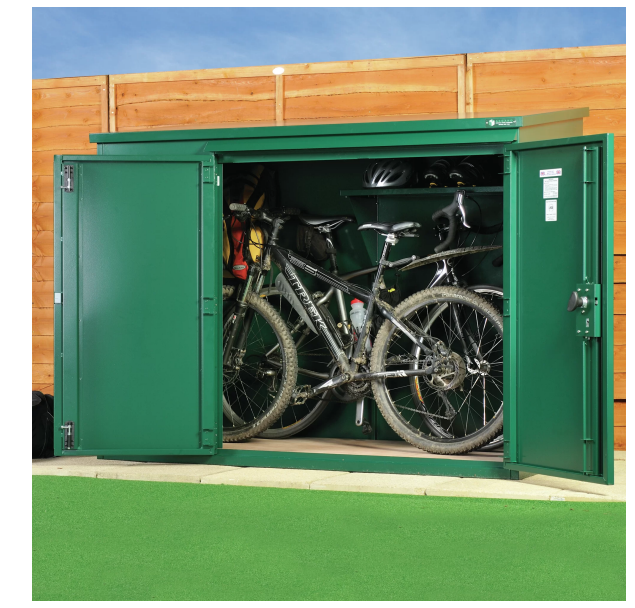
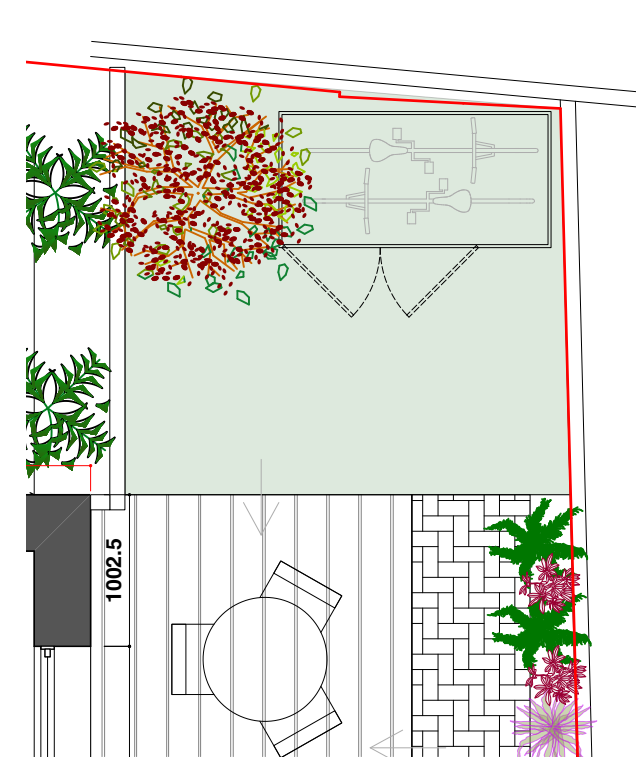
1 BIKE STORE ELEVATIONS - FRONT

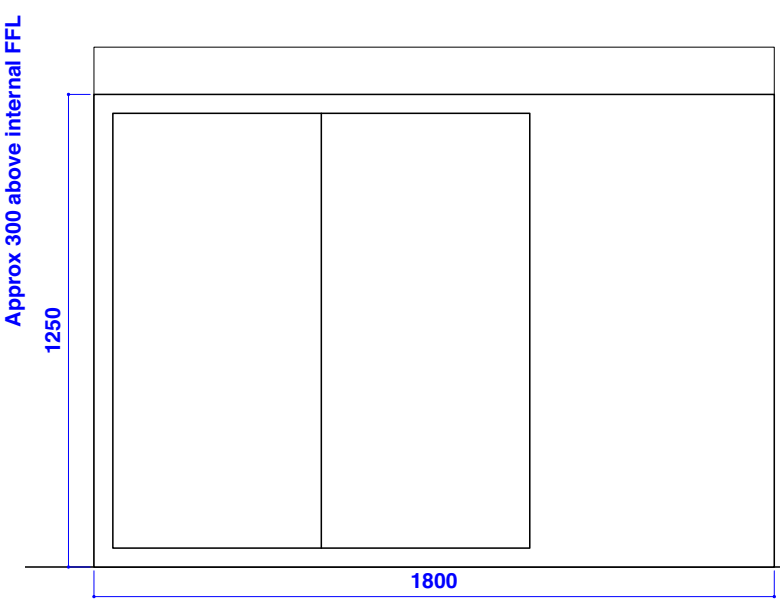


3 SECURE BIKE STORE - HOUSE 2

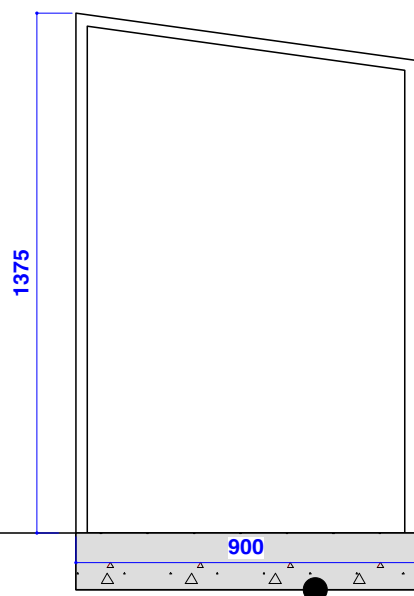


Annexe 6 ft. W x 3 ft. D Pent Metal Bike Shed by Asgard

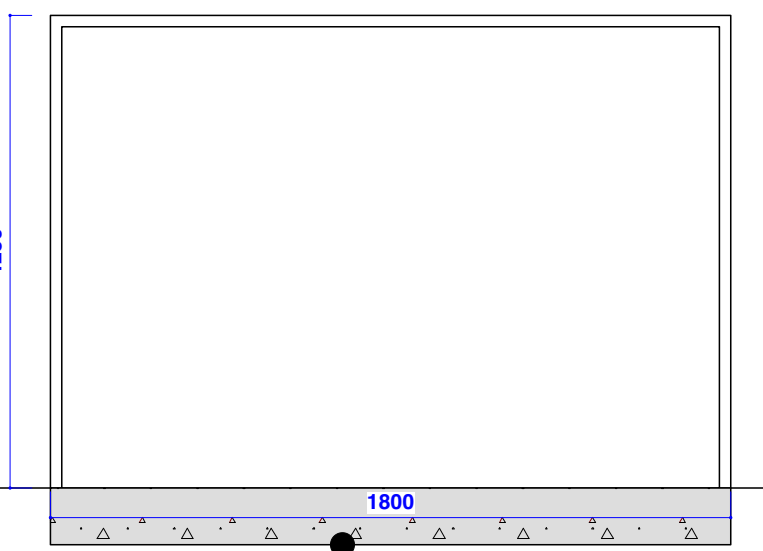
