NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

FRONT GARDEN: 1 x Fig (T1) - Reduce crown by approx. 40cm above previous pollard points.

REAR GARDEN: 1 x Hornbeam (T2) - Reduce crown by up to approx. 1.25m - 1.5m.

1 x Holly (T3) - Reduce crown by up to 1m.

2 x Limes (T4 & T5) - Pollard. Reduce height by approx. 1.5m back to previous and most recent pollard points. Trim back lateral and sub lateral growth by approx. 1m.

1 x Pear (T6) - Reduce crown by approx. 1m, reducing over long extraneous branches back into main crown structure.

1 x Paulownia (T7) - Reduce lateral and sub lateral growth back from the garden by approx. 1.5m. To create a more compact upright crown structure.

1 x Hazel (T8) - Reduce by approx. 1.2m. to control encroachment.

The Council has considered your notification of intended works to trees dated 12 September 2022 and does not wish to object.

Informative(s):

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, which ever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
