Rear Garden:	
T1: Bay tree: Approximately 7.00m: Section fell to ground level and treat with systemic herbicide. Poor crown structure, overcrowded and growing into the crown of a mature Cherry. Replanting/re-landscaping.	
T2: Mature Elder: Approximately 6.00m: Reduce overlong extraneous branches back into main crown structure, approximately 1.50m. Reduce crown overhanging Chalcot Square by approximately 1.00m to control encroachment. Remove dead wood throughout crown. Lightly thin crown density by 15%-20%. General maintenance.	
T3: Willow: Approximately 7.00m: Reduce crown back to previous and most recent reduction points, approximately1.50m. General maintenance.	
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
