Rear Garden:

- T1: Mature Bay (lefthand boundary): Approximately 9.00-10.00m. Reduce crown by approximately 1.20-1.50m all round as is practicable. Raise crown by up to 1.00m.
- T3: Apple: Approximately 8.00m. Reduce overlong extraneous branches back into main crown structure, up to 1.75m and thin crown density by 20%, forming a more compact balance crown structure.
- G1: Group of Multi-stemmed Bays: Approximately 9.00m. Fell to ground level and allow to regenerate. The new stems to be maintained a a hedge.

Reason: To increase light levels as this area of the garden is rather dark and overcrowded. The Bays have now formed a dense clump.

T5 & T6: 2 x Norway Maple: Approximately 9.00m. Raise crowns over shed area by up to 2.00m. Reduce Ivy by approximately 1.50m, retaining the central Ivy mass as screen and natural habitat. Reduce dead wood throughout crowns.

T7: Buxus: Approximately 5.00-6.00m. Fell to ground level and grind stump to approximately 300mm below current ground level. Reason: This tree is in poor condition and form and of low amenity value.

T8: Mature Holly: Approximately 8.00m. Fell to as near to ground level as is practicable and treat with systemic herbicide. Reasons: The tree is in fairly poor condition and growing within close proximity of the more important Holm Oak adjacent.

T9: Holm Oak: Approximately 13.00m: Thin crown density throughout by approximately 20-25%. Reduce back to previous reduction points approximately 2.00m, whilst preserving a suitable amount off furnishing growth.

T10: Sorbus - (located close to the house): Approximately 9.00m. Reduce crown by 1.20-1.50m. Thin crown density throughout by 20%.

Reason: General maintenance unless otherwise stated.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - o mark and name surrounding roads
 - o sketch in buildings, including adjoining properties
 - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - $\circ\,$ adding other relevant features on the site (e.g. greenhouse, paths)
