T1 Indian Bean Crown Reduction - Reducing the height and spread of the tree by up to 3.5metres.

T2 Birch Fell and dig out stump.

Fell to ground level and grind stump to approx 300mm below ground level. T3 Magnolia T5 Crabapple Crown Reduction - Reducing the height and spread of the tree by up to 3 metres T8 Birch Crown Reduction - Reducing the height and spread of the tree by up to 2 metres.

Crown Reduction - Reducing the height and spread of the tree by up to 3 metres - clients side only. T9 Sycamore T10 Ash Crown Reduction - Reducing the height and spread of the tree by up to 3 metres - clients side only.
