### **NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA**

Proposed Work:

REAR GARDEN: 1 x Holm Oak (T1) - Trim sides and bottom of crown by up to 1m with hedge cutters to produce cylindrical shape.

1 x Holm Oak (T2) - Trim sides and bottom of crown by up to 1m with hedge cutters to produce cylindrical shape, trim top harder to bring it closer in height to T1.

1 x Holm Oak (T3) - Trim all aspects of crown with hedge cutters by up to 1m.

2 x Limes (T4 & T5) - Reduce crown to previous pruning points, approx. 2m, thin epicormic shoots on main stems by approx. 25%.

The Council has considered your notification of intended works to trees dated 19 July 2022 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by

the Council.

- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Of particular note is the protection offered to bats, birds and their nests from construction works.
