NO OBJECTION TO SECTION 211 NOTICE OF WORKS TO TREE/S IN A CONSERVATION AREA

Proposed Work:

REAR GARDEN: 1 x Magnolia (T1) - Reduce crown height by approx. 1m

1 x Acer (T2) - Reduce crown by approx. 0.5m. Thin upper crown density by 20%.

1 x Birch (T3) - Thin crown density by 15% - 20%. Reduce lateral and sub lateral branches back from the building by up to 1m. General maintenance.

1 x Birch (T4) - Thin crown density by 15% - 20%. Reduce back from neighbouring garden by approximately 1m.

Group of Magnolia Grandiflora (G1) - Reduce lateral and sub lateral branches growing over neighbouring property by approx. 1m.

1 x Bay (T5) - Reduce height by up to 1.5m. Reduce lateral and sub lateral branches by up to 30cm.

1 x Bay (T6)- Reduce rear branch back into main crown structure approx. 2.5m reduction. Reduce remaining crown by approx. 1.5m to reshape.

The Council has considered your notification of intended works to trees dated 02 August 2022 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is

completed, whichever is the sooner.

- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
