Proposed Work:

IN REAR GROUNDS: 1 x Cedar (Cedrus deodara) (T240) - Fell to ground level and grind stump.

- 1 x Cherry Plum (Prunus cerasifera) (T200) Reduce height by approx. 2m and crown spread over garden by 1.5m to balance, to reduce stress on weak forks.
- 1 x Hornbeam (Carpinus betulus) (G202 in centre) Fell to ground level.
- 1 x Cherry (Prunus avium) (T210) Reduce height by 1.5m and reduce crown spread to leave at least 1m clearance to buildings.
- 1 x Mimosa (Acacia dealbata) (T239) Reduce height by 2m and crown spread by 1m in all directions to balance.
- 1 x Sycamore (Acer pseudoplatanus) (T39) Reduce height by 4m and crown spread towards buildings by 2m.
- 1 x Sycamore (Acer pseudoplatanus) (T42) Reduce height by 4m and crown spread by 2m in all directions.
- 2 x Cotoneaster (G212) Reduce height by 1.5m.
- 2 x Cotoneaster (G225) Reduce height by 2m.
- 1 x Lime (T67) Reduce height by 3m.
- 1 x Lime (T66) Reduce height by 3m.
- 1 x Hornbeam (T108a) Fell to ground level.
- 1 x Horse Chestnut (Aesculus hippocastanum) (T106) Carry out 20% crown reduction as

indicated on photo included as Appendix F.

- 1 x Birch (Betula pendula) (T101) Fell to ground level and grind stump.
- 1 x Mimosa (Acacia dealbata) (T236) Reduce height by 2m and crown spread by 1.5m in all directions to balance.

The Council has considered your notification of intended works to trees dated 24 August 2022 and does not wish to object.
