- Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. ## Conditions and Reasons:

Prior to the end of March 2023, a single-stemmed scots pine tree (Pinus sylvestris) 12-14cm in circumference at 1m above the base of the stem shall be planted within 5m of the location of the application tree unless otherwise agreed with the council in writing. The tree shall be planted in accordance with the standards set out in BS5845:2014. Should the tree die or become seriously diseased within five years of planting it shall be replaced with a tree of the same specification.

Reason: To comply with s.206 of the Town and Country Planning Act 1990 (as amended)
