Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1 - Beech

Prune the northern lateral canopy extents by up to 3 m to establish a 3 m clearance zone between the canopy extents and the existing building

Prune the southern, eastern and western lateral canopy extents by up to 2 m.

Crown thin the overall canopy volume by up to 20 % focusing on tertiary foliage

Reason - the tree canopy is touching the existing building and the proposed pruning to the northern extents will establish a sustainable relationship between this area of the tree canopy and the building. The pruning to the other canopy extents will ensure that overall the tree's canopy extents remain broadly symmetrical. The proposed thinning will improve light levels to the existing courtyard area below the tree - which is an area of communal recreation.

T2 - Lime

Prune to points of most recent pruning. This work will equate to an overall canopy reduction of up to 3 m (in height and lateral extents) and will result in a tree with a radial canopy extent of 5 m.

Reason - this tree has been subject to similar past pruning and has responded positively with vigorous growth across its canopy extents. The proposed works will align to the objectives of past pruning management and ensure that this tree remains a sustainable asset to the location.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
