Reason - the tree is dead.
T7 - Acacia - Fell and poison/remove stump
Reason - This acacia is a very low-quality tree located in an unsustainable location within the property. It is clearly having an adverse impact on the structure of the boundary wall (assumed to be a shared ownership wall), and it is reasonable to advance that its continued presence and growth will lead to the wall being compromised.
