## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Removal and stump grinding of the following trees (listed below and in reference to plan provided) to alleviate potential root plate failure and impact to third party property and adjacent PRow and to enable boundary improvement works. These trees are more exposed to windthrow from not only storm damage in recent years, but also previously approved tree works (Ref: 2019/3153/T and 2022/2026/T). Construction works and future built form in close proximity to these trees means that their retention in the long-term is realistically unsustainable.

In addition, these trees are considered inappropriate for retention given the growing medium of made-up ground and therefore removal and replacement with up to 8 trees along this boundary is proposed. These will be planted in an improved structured boundary with trees in a minimum top soil depth of 950mm. The details of replacement boundary planting will be included in a NMA Application due for submission w/c 31st October 2022.

Trees are proposed for removal via Section 211 as construction works for consented scheme are underway and access to this part of the site will soon be impractical for both arboricultural personal and machinery, as built form will prohibit access to this part of the site.

- T002 - Sycamore
- T003 - Common Ash
- T004 - Aspen
- T005 - Common Ash (offsite tree with permission from Royal Mail)
- T006 - Lime

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
