T1 Front Garden - Negundo maple tree: Section Dismantle / Fell to ground level and grind out stump Reason: Small insignificant poor formed specimen, replanting

T2 Prune the Plum tree to the following specifications: • Clean to remove all dead, diseased, or crossing branches • Thin / Reduce by (30)% of the live branches throughout the canopy to (allow more light and air penetration throughout the canopy and shape) Reason: Routine maintenance

T3 Prune the Pear tree to the following specifications: • Clean to remove all dead, diseased, or crossing branches • Thin / Reduce by (30)% of the live branches throughout the canopy to balance (allow more light and air penetration throughout the canopy and shape) Reason: Routine maintenance

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\,$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ~$  showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
