- Plan and conduct other security control audits to assess compliance with company Information Security Policies and Requirements
- Report on the design and operation effectiveness of Information Security Controls
- Monitor progress of corrective actions against remediation plan

- Internal Document control and maintenance
- Providing advice to the organisation and ensuring that security standards are understood and complied with
- Conducting regular reviews of application requests from Camden colleagues to ensure our data remains secure
- Researching and evaluating emerging cyber security threats
