Proposed Work:

REAR GARDEN: 1 x Pear (T1) - Remove broken and hanging branches throughout crown.

- 1 x Sycamore (T2) Thin crown density by 20% 25%. Reduce overlong extraneous branches back into main crown structure up to 1.5m 2m reduction. To produce a more compact crown structure. Raise crown by approximately 1.5m.
- 1 x Sycamore Sapling (T3) Fell to ground level.
- 1 x Ash (T4) Re-pollard back to previous and previous points, selecting furnishing growth where practicable to help ensure crown continuity.
- 1 x Holm Oak (T5) Reduce back to clear building by 1m 1.5m. Reduce crown height by approx. 1.5m.
- 1 x Ash (T6) Reduce crown by approx. 2m 2.5m all round. Thin crown density by 25%.

The Council has considered your notification of intended works to trees dated 26 September 2022 and does not wish to object.
