Horse Chestnut T1 (18M high, 700mm dia.) - TPO. Raise canopy on SW side mainly over the road by removing 4 lowest lateral branches back to growth point and shaping in to create more uniform crown to the tree. Thin internal crown by up to 15% to allow more air and light through the tree (dense canopy).

Reason: Structural prune to improve balance of the tree especially over the road. Improve available natural light to the garden area on the corner

japanese Maple T2 (8M high, multi-stemmed) - Raise crown to clear the side wall on Willow Road and careful light thin of crown.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - $\circ\;$ adding other relevant features on the site (e.g. greenhouse, paths)
