The external finish of the cabin consists of 70 x 34 stud framework, clad with 9mm plywood and plastisol sandwich panel to form a stressed skin construction. The Britannia's steel sandwich panel consists of 0.5mm plastisol, 9mm plywood and a 0.5mm steel balance sheet to the rear side.

The roof is drained via fallpipe at each soffit end of the roof.
