XXL Sycamore (T1) - fell because it's completed. It is a hazard because it may fall on the buildings because it is close to the rear of two houses. XXL Sycamore (T2) - 30% because it is over grown and it is too high. XXL Sycamore (T3) - 30% because it is over grown and it is too high. Small Willow tree (T4) - fell due to causing damage to the property. It's starting to lift push the pavement and push the stairs. Cherry (T5) - 30% full crown reduction because it's too big. XXXL Sycamore tree (T6) - 30% because it is over grown and it is too high. Server the ivy also. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
