T1 Beech rear right hand side boundary

Goals:

- Crown reduction by removing 2.0 to 2.5 metres growth in height and spread pruning back to suitable growth points to leave a balanced crown, using hand tools only to give the best finishing cuts.
- Reduce live branches as needed

Species Location

T2 Laurel rear right corner boundary

Goals:

- Crown reduction by removing 2.0 metres growth in height and spread pruning back to suitable growth points to leave a balanced crown.

Remove dead wood and any dead stems.

- Reduce and/or remove dead, live branches as needed

T3 Birch rear right corner boundary

Goals:

- Crown reduction by removing 1.5 metres growth in height and spread pruning back to suitable growth points to leave a balanced crown, using hand tools only to give the best finishing cuts.

Prune back from building to give sufficient clearance.

- Reduce live branches as needed

Species Location

T4 Laurel rear boundary

Goals:

- Crown reduction by removing 2.0 metres growth in height and spread pruning back to suitable growth points to leave a balanced crown.

Remove dead wood and any dead stems.

- Reduce and/or remove dead, live branches as needed

T5 Cherry front right hand side boundary

Goals:

- Crown reduction by removing 2.0 metres growth in height and spread pruning back to suitable growth points to leave a balanced crown, using hand tools only to give the best finishing cuts.
- Reduce live branches as needed to be done in summer

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

### Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
