TERMS AND CONDITIONS

1. Payment:

To place all orders we require a 50% deposit, and the balance payable with cleared funds on delivery of undamaged goods. We require details and sizes to be provided for all orders (for any assistance please contact our helpful team or book in a visit to see us). All products remain the property of Marlin Windows Ltd until paid for in full. Our estimates are subject to final survey, designs, specifications and structural calculations.

3. Delivery

All of our quotations include for delivery unless stated otherwise.

Please make sure that there is adequate site help/lifting equipment to assist in the off loading of heavy frames and glazing with appropriate access for large vehicles. If our delivery cannot be completed for any reason, (e.g. inadequate site assistance) we will have to return the products to our factory and a reasonable fee will be charged for storage and a rearranged delivery.







4. Replacements/returns

Whilst our aim is to provide a product of the highest standard we do however have some cases where part of a product may need to be replaced or is faulty. This relates mainly but not limited to glass units or hardware. If you have received something that is not fit for purpose, please contact the office within 48 hours of receiving the delivery and we will do our best to replace the faulty item as quickly as possible. Please note we cannot be held responsible for any additional costs incurred (i.e. return visits to site for installers/contractors, extension periods on scaffolding, other ongoing works/trades etc.

5. Amendments and revisions

We reserve the right to re-price should any of the details or sizes change within an order. Please note if an amendment is made to an order that has already been placed, or for an installation that has been surveyed and agreed, then the costs already incurred for these items will be charged accordingly.

6. Colours

All of the aluminium sections have a single non-metallic polyester powder finish, from the extensive standard RAL matt colour range available to our company. Please note that all metallic colours and infrequently specified colours which are not stocked by our applicators incur an additional charge. Dual colour options are available at an additional cost.

7. Ancillary parts

Frame build ups, trickle vents, add-ons, extensions and aluminium pressings etc are not included in this estimate. (Unless specified otherwise). All curtain wall items do not include fixing brackets as they have to be calculated and surveyed on site.

8. Warranty

We provide a manufacturers guarantee for a full 10 years, with 5 years on glazing and 1 year on hardware. Standard powder coated paint finishes are guaranteed up to 25 years against the following faults:

- Peeling, powdering and blistering
- Corrosion except due to bending or folding after the application of the paint
- Chalking, fading and loss of sheen out of the qualicoat regulation
- Filiform corrosion

Coastal or hazardous environment projects are subject to an application to the paint manufacturer. **Note:** All warranties will become invalid if products are taken overseas.

9. Discounts

Volume discounts and MCD's have been applied to our estimate.

10. Location/Weather

Our offer is based on historic weather information that is available from the Met Office. It is vital that you inform us of known geographical weather conditions that are not on record but are specific to your location. This is so that we can advise you on product suitability for the purposes of weather performance.
