Front garden

T1 Lime x 1 (Tilia spp) This tree is in a poor condition with a large infected wound at approx. 1.5m and smaller wound with little to no healing wood at the top of the only remaining stem. This tree is also damaging property. Suggested works:

- Fell to ground level by sectional take downusing advanced rigging technique
- Poison stump to prevent re-growth

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
