I am writing to comment on the planning application 2022/3853/P. I note that the development will focus on the introduction of new exhibition spaces, installation of new retail shop fronts within West Yard, opening up of Dead Dog Basin and the erection of a temporary observation wheel.

I am particularly supportive of the following aspects of the development:

The development will open up the East Vaults and Dead Dog Basin spaces to the public and local community for the first time and it is welcomed that this will focus on the history of the Regent's Canal, as well as aspects of the railway Goods Yard and Camden Market.




