The proposed work is a replacement of single-glazed windows with new slim lite double-glazed windows. Most of the proposed windows will be in the same material, size, colour and position but with an improved thermal performance to the flat. Just two uPVC windows at the North-East Facade will change to the original design to match the existing windows of the whole building.

The proposal represents a great opportunity to upgrade an energy inefficient building. All windows will be supplied by the same manufacturer that has provided the replacement windows to several other flats in the building in recent years.
