- The cultural plan makes it clear about the importance of highlighting equality, diversity and inclusion within the exhibition spaces. and would showcase arts and performances relevant to those communities recognising the contributions of Black, Asian and other ethnic groups by offering them a platform to showcase their talents. Working with partners to interpret the new exhibition spaces is critical and the aim is to deliver a number of key festivals, such as Black History Season, South Asian Heritage Month, Pride Month and Holocaust Memorial Day.

- There would be collaboration with the Higher Education sector such as the University of the Arts - London Central Saint Martins, with the aim of working with MA Design students to co-design the layout of the exhibition spaces.

education due to family restrictions.*

- The development of the East Vaults into exhibition spaces would attract a greater array of family visitors and offer family learning opportunities through journey trails including virtual reality headsets exploring the Canal and the market from early days. The development would aim to have an immersive experience which highlights the iconic musical and fashion heritage of Camden Lock Market and Camden Town. This would also allow for a new local emerging musical and creative talent to be showcased.

*-As long as it is affordable for the local community.*

- The restoration of 'Dead Dog Basin' is a unique opportunity to create a high-quality destination experience. The aim is to open up and restore this underground water basin heritage asset for the first time to provide; new and iconic embarkation and disembarkation point for the passenger water boats; an inspiring 'canvass' to showcase Light sound and street artists and projectionists.

*- I love the idea as I have been to other parts of London with similar concepts which are very diverse and bring extra revenue to the local community.*

- The proposed temporary observation wheel would allow for an iconic unbridled view of the Camden Market's heritage buildings from above as well as Regent's Canal and the landscape of London, from Paddington in the West to Limehouse in the East. The observation wheel would ensure an allocation of free and heavily discounted tickets to a limited cohort of local school students from disadvantaged communities.
