Reduction from lamppost side (west) 2 metres bringing tree to 1 metre inside cemetery boundary. This tree is currently making footpath/ slope inside council estate slippery.

T317 London plain tree on East Cemetery boundary wall.
Reduction of 4 to 5 metres bringing the tree to 1 metre inside the cemetery boundary. and a further Reduction on the west side by 2 metres to bring tree to 1 metre inside the cemetery boundary. This tree is currently making the footpath/ slope inside the council estate slippery.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
