Silver Birch T1 - reduce crown to points of previous reduction (3m approx. height reduction, 2m from side branches) Trees approx. current height 15m

Reason - this tree is growing in a small front garden space with limited available space between the property and the public highway. In the interests of public safety and within the remit of good arboricultural practise, the crown is being maintained in a reduced form

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
