## Identification of Tree(s) and Description of Works

T1 Ash x 1 (Fraxinus excelsior) This 13m ash tree is located 3.5m from the rear of the house. The tree has been given a 1-1.5m crown reduction every 2-3 years. Despite significant furnishing growth being left on the tree there was a considerable amount of dieback when the tree was last pruned in October 2022. The last 0.3-1m of every branch end had died.

The trees' location means it has to be pruned this regularly, however ash does not respond well to regular pruning. A juxtaposition that now needs addressing.

In addition to the significant dieback there are other issues with the tree including: a partially included wound 3m up the trunk with 15cm of decay in the wound; fruiting bodies in the crown break; the large buttresses and extensive root network have lifted all the paving slabs and caused a large crack in the retaining wall.

This ash tree has relatively low amenity value and its removal would allow the fig tree planted beneath it to thrive. Currently the fig tree is being suppressed by the ash. Suggested work:- fell to ground level using advanced rigging techniques- leave stump just above the buttress height in order for the stump to be used as a platform for plant pots

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
