The proposed kiosk would impede the pedestrian traffic on a footpath that has to accommodate pedestrians using Finchley Road tube station, the road crossing outside the tube station and the row of shops between the tube station and Canfield Place.  The application gives the address as 219 Finchley Road. However, the application is to erect the kiosk on the public footpath on Canfield Gardens between the tube station and the bus stop. Finchley Road tube station is a busy station serving both the Metropolitan Line and the Jubilee Line. The bus stop serves the C11 bus and rail replacement busses if one of the tube lines is out of service. That stretch of Canfield Gardens accommodates busy traffic. A hot food kiosk with any customers queuing outside it would create a dangerous blockage on a busy public footpath beside a busy road. To approve the application would be reckless.
