## **DECISION**

Proposal: Erection of a rear roof dormer window and one front rooflight

Drawing Nos: LR.01.01, LR.01.03, Planning Statement.

The Council has considered your application and decided to grant permission subject to the following condition(s):

Condition(s) and Reason(s):

1 The development hereby permitted must be begun not later than the end of three years from the date of this permission.

Reason: In order to comply with the provisions of Section 91 of the Town and Country Planning Act 1990 (as amended).

The development hereby permitted shall be carried out in accordance with the following approved plans: LR.01.01, LR.01.03, Planning Statement

Reason: For the avoidance of doubt and in the interest of proper planning.

All new external work shall be carried out in materials that resemble, as closely as possible, in colour and texture those of the existing building, unless otherwise specified in the approved application.

Reason: To safeguard the appearance of the premises and the character of the immediate area in accordance with the requirements of policy D1 and D2 of the London Borough of Camden Local Plan 2017 and policy 2 of the Fortune Green and West Hampstead Neighbourhood Plan 2015.

## Informative(s):

1 Reasons for granting permission:

The proposed rear dormer window is considered acceptable in terms of size, form and design. This is due to its modest size where it is set in from the eaves, sides of the roof and from the ridgeline. It would serve a snug area and bathroom. The dormer would relate to the window proportions below and would sit comfortably within the existing roof and reflects the varied roof forms within the surrounding area. The materials would match the main property and would be in keeping with the character of the area. The proposed front single rooflight, would be appropriately placed and set flush within the roofslope, in keeping with other similar rooflights in the street. Therefore the proposal is considered to preserve the character and appearance of the West End Green Conservation Area.

The proposed rear dormer window and front rooflight would not harm neighbouring amenity in terms of overlooking or loss of light.

The West End Green Conservation Area Advisory Committee raised no objection to the proposal. One objection has however been received by a neighbouring property which is duly considered within the attached summary of consultation. The site's planning history was taken into account when coming to this decision.

Special attention has been paid to the desirability of preserving or enhancing the character or appearance of the conservation area, under s.72 of the Planning (Listed Buildings and Conservation Area) Act 1990 as amended by the Enterprise and Regulatory Reform Act (ERR) 2013.

As such, the proposal is in general accordance with Policies D1, D2 and A1 of the Camden local Plan 2017 and policy 2 of the Fortune Green and West Hampstead Neighbourhood Plan 2015. The proposed development also accords with the policies of the London Plan 2021 and the National Planning Policy Framework 2021.

Your proposals may be subject to control under the Building Regulations and/or the London Buildings Acts that cover aspects including fire and emergency escape, access and facilities for people with disabilities and sound insulation between dwellings.
