"PIZZA" black metal casings, acrylic faces, internally illuminated by LEDs. "KITCHEN" built-up letters with halo lighting to rear (lighting a shadow plate behind the letters).
3. 2x poster/menu boxes. Metal casings with clear acrylic faces, internally illuminated by LEDS. For showcasing menus and posters.
4. 1x poster/menu boxes. Metal casings with clear acrylic faces, internally illuminated by LEDS. For showcasing menus and posters.
