Remove all regrowth (approx. 1m) back to old pruning points

Remove trunk and basal growth as per previous practice.

T4 & T5 = 2 x Large Limes

Remove all regrowth (approx. 1 m) back to old pruning points

Remove trunk and basal growth as per previous practice

Sever Ivy at 4m
