The Council confirms that the remedial works as described above are exempt from the need for further notifications or any formal application to the Council and you are therefore allowed to proceed.

Informative(s):

- 1 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife. Conditions and Reasons:

Prior to the end of March 2023 a hornbeam tree (Carpinus betulus) with a stem circumference of 14-16cm at 1m above the base of the stem shall be planted in the front garden of the property unless otherwise agreed with the council in writing. The tree shall be planted within 3m of the location of the application tree, no less than 750mm from structures and in accordance with the standards set out in BS8545:2014.
