Assessment

The s.211 notification is for the removal of two cypress trees and the pruning of an elder tree from the front garden, and the removal of another elder and pruning works to a Norway maple in the rear garden from a residential property that is situated within the Elsworthy Conservation Area.

The cypress trees and the elders are visible from the public realm but are not considered to significant contribute to the character and appearance of the conservation area due to their relative small size.

The cypress trees have become engulfed by climbers which has affected the foliage lower down the trees. The dead foliage will not regenerate on this coniferous species The cypress trees are not considered to be noteworthy examples of their species.

The front garden elder is in extreme close proximity to the front elevation of the property and is engulfed in ivy and Wisteria to the point whereby the elder is barely visible.

The rear garden elder is visible from the public realm but is a shrub that is likely self-sown. While this does not automatically devalue the elder, it has in this case resulted in the elder growing in extreme close proximity to the boundary wall. It is not considered to be a noteworthy example of its species and is not of a rare species.

The rear garden pruning works are considered minor in nature and to not be harmful the character and appearance of the conservation area.
