T1 - wisteria climber - sever as much as possible from the ground with poles.			
T2 - purple plum tree (7m) - thin crown over table by removing two particular branches.			
T3 - palm tree (5m) - remove overhanging leaves.			
T4 - fig tree (3m) - remove low branches growing over trellis and reduce height to approximately 2.5m.			
T5 - hazel tree (6m) - remove two thickest stems and stem on right growing over shed.			
T6 - mulberry tree (8m) - remove lowest branch on right.
