About Camden

In Camden we want the borough to be the best place in London to grow up, and as an Assessing Social Worker in the Permanence Team you will be a key part of this vision. You will assess and support family and friends who put themselves forward to care for children under Special Guardianship Orders, when can no longer live with their parents. The goal is to give those children the best possible start in life within their wider family. We recognise that children are usually best off when living within their families, and that we want to provide those families the support they need to care for those children.

About the role:

As a Friends and Family Assessment Social Worker you will conduct assessments of adults who want to provide a home to children who cannot remain in the care of their parents. The role will include conducting viability (i.e. initial) assessments, and full Special Guardianship Order Assessments of prospective carers in care proceedings, assessments for private SGO applications, Kinship Fostering Assessments and supporting social workers in other teams to think about how to ensure children can achieve permanence. You'll have the opportunity to work with professionals of every discipline and with a remit spanning the assessment and support of family and friends' carers, special guardians, and long-term foster carers, you're guaranteed different challenges every day.

The Permanence Team is part of an integrated service comprising the Children Looked After team, Virtual School, Specialist health team, Looked After Children's CAMHS provision, and the Fostering Team.

You will share and exercise the organisational practice ethos defined by The Camden Model of Social Work ([link](#)) which places systemic practice and strong relationships at the heart of working with families.

About you:

It is essential to the role that you hold a Diploma in social work, or equivalent qualification, with a minimum of two years post-qualification experience as a social worker. You must also be Social Work England registered.

You must have proven experience of undertaking assessments of individual needs and/or risk; of designing and implementing care/protection/SGO support plans; of monitoring and reviewing such plans over a period of time; preparing for and giving evidence in care proceedings. As well as experience of working with connected persons, special guardians and foster carers.

You will have the ability to investigate family circumstances and make assessments of a child or carer's needs and risks to their wellbeing, as well as build and maintain effective working relationships at all levels, internally and externally in order to influence others and get things done for the benefit of the families you work with. You will make use of the most up to date research evidence, statutory guidance and best practice models to inform your analysis and recommendations. You will also be committed to working in a culturally competent, sensitive manner, taking into account Camden's commitment to becoming an anti-racist organisation. You will take responsibility for your own work, consistently achieving and delivering high quality work in a timely manner, whilst balancing competing priorities.

To be successful in this role you will need great negotiation and influencing skills and ability to deal with conflict, hostility and vulnerability. Be an excellent communicator and be able to establish positive and effective working relationships with children, young people and families to ascertain their wishes and engage them in decision making processes.

Work Environment:

This role is based at the Crowndale Centre in Camden Town, close to Mornington Crescent Tube Station. However, there is a mixture of office based, home working and face to face appointments in the community with children and families.

You will work with the Team Manager, and your Line manager, as well as other social workers in the team, and across children's services to complete high quality assessments of the friends and family members, to ascertain whether they can look after some of our most vulnerable children. You will also be required to build positive relationships with people who use our services, and other professionals from external agencies, such as Adopt London North (the Regional Adoption Agency), health, mental health, other local authorities, and the police.
