Details pursuant to Condition 12 (Photo Voltaic Cells) of planning permission reference 2016/6088/P dated 30/06/17 as varied by planning reference 2018/5774/P dated 29/03/19 for redevelopment of the existing Highgate Newtown Community Centre and Fresh Youth Academy and the change of use of the People's Mission Gospel Hall to provide replacement community facilities (Use Class D1) and 31 residential units (Use Class C3) with associated public open space, landscaping, cycle storage, plant and disabled parking.

#### 1 Reasons for granting permission-

detailed roof plan showing the PV Panel, as required by the planning condition.
