Robinia (1) This tree is situated at front left side of property, I propose to reduce height by approx 3m, reduce width by approx 2m to shape accordingly

Hawthorn (2) In front boundary overhanging pavement and leaning towards building, to reduce crown by approx 1m more than previously (approx 2.5m in height and width)

Hawthorn (3) By right boundary at front to reduce by approx 2m in height and shape accordingly

Birch (4) Birch tree on right side to lightly prune as previously by approx 1m and shape accordingly

Lime (5) Lime tree by right side of building to reduce as previously by approx 2m in height and reduce width away from building

Paper Bark Birch (6) To prune back branches away from Cypress tree and away from building, remove dead low stem and reduce height by approx 2m

Cypress (7) To reduce height by approx 3m

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - $\circ~$ showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
