T1 - sycamore sapling tree (4m) - take down to ground level and poison stump.

T2 - lime tree (7m) - reduce crown to previous pruning points, approximately 3m reduction.

T3 - lime tree (12m) - reduce crown to previous pruning points, approximately 3m reduction.

T4 - lime tree (13m) - reduce crown to previous pruning points, approximately 3m reduction.

T5 - lime tree (12m) - reduce crown to previous pruning points, approximately 3m reduction.

T6 - lime tree (14m) - reduce crown to previous pruning points, approximately 3m reduction.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ\;$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
