- 1 x Norway Maple (T20) Prune to provide 2m clearance from adjacent property/street furniture and crown raise to 5m to clear the public highway.
- 1 x Norway Maple (T22) Crown raise to 5m.
- 1 x Whitebeam (T23) Prune to provide 2m clearance from adjacent property/street furniture.
- 1 x Hornbeam (T25) Crown raise to 5m over public highway.
- 1 x Whitebeam (T26) Prune to provide 2m clearance from adjacent property/street furniture.
- 1 x Silver Birch (T28) Prune to provide 2m clearance from adjacent property/street furniture.
- 1 x Narrow Leaf Ash (T29) Prune to provide 2m clearance from adjacent property/street furniture.
- 1 x Silver Birch (T31) Crown raise to 5m to clear public highway.
