Proposed Work:

IN GROUNDS (SEE PHOTO): 1 x Sycamore (T1) - Reduce lateral growth over property by up to 2.5m to provide 1.5m clearance.

1 x Sycamore (T2) - Reduce lateral growth over property by up to 2.5m to provide 1.5m clearance.

1 x Apple (T4) - Crown lift to 2m; reduce away from property.

1 x Gleditsia (T5) - Crown lift to 2m.

1 x Cherry (T6) - Fell to ground level.

1 x Sycamore (T7) - Fell to ground level.

1 x Beech (T8) - Fell to ground level.

1 x Rowan (T9) - Fell to ground level.

1 x Prunus (T10) - Fell to ground level.

1 x Atlas Cedar (T11) - Fell to ground level.

1 x Gleditsia (T12) - Reduce overall crown by up to 2m to provide tidy and consistent form.

1 x Beech (T13) - 20% volume reduction (by thinning and drop-crotching, secondary growth only). Overall crown reduction by up to 2.5m.

The Council has considered your notification of intended works to trees dated 10 November 2022 and does not wish to object.

- 1 This notice is valid for 2 years from the date of this letter or until the work is completed, whichever is the sooner.
- 2 You are advised that the appropriate standards for tree work are set out in BS 3998: 2010. Failure to ensure that the proposed works are carried out to these standards may result in damage to the tree(s) and may result in legal action by the Council.
- 3 Please note that any approval given by the Council does not give an exemption from the requirements to comply with the Wildlife and Countryside Act 1981 (as amended), or any other Acts offering protection to wildlife.
