Trees 648, 649, 650 on accompanying location plan - all Cockspur Thorns.
Works: Raise lower canopies of all three trees to 2.5m.
Reason: general arboricultural management
Tree 647 on accompanying location plan - London Plane. Works: Cut back off building on opposite side of road and adjacent building to provide 2m clearance.
Reason: general arboricultural management

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
