Details of the pre-application advice received

Please note that the pre-application proposal was for a larger building and provision of 24 apartments rather than the current scheme of 15 apartments and 184 sqm office space. The current proposal has been significantly reduced in size and scale and seeks to carefully consider the impact on the residential amenity of occupiers of neighbouring buildings.

Summary of advice received: The proposal did not propose an acceptable scale, bulk and massing and did not relate sufficiently well to the existing context. It would impact on the residential amenity of the neighbouring occupiers in terms of loss of daylight, sunlight, outlook and privacy. It is suggested that future proposals are significantly reduced in size and scale. The proposed dwellings did not provide an appropriate standard of accommodation to future occupiers and need to meet nationally described space standards. The loss of the existing employment floorspace has not been sufficiently justified.
