Details of the pre-application advice received

The existing rear studio must be keep as a separate entity to the house; its structural integrity should be conserved; alterations could take place at the roof level, to improve the energy efficiency of the building; the studio could hold a mezzanine level subject to detailed design; no windows in the rear boundary wall would be accepted; chimney breast and chimney stack should be retained. Further investigation of the studio floor must be undertaken prior to a BIA; if modern then proceed with further details; the proposed basement should be significantly reduced in scale; this has to be supported by a BIA. Further investigation to the age of the closet wing; its retention within a future

Further investigative works are necessary to determine the age of the partition walls at upper levels; significant consideration should be given to the impact of plumbing for the proposed bathrooms to the historic fabric.

The reduction of the front mansard terrace is welcomed as well as the removal of the plastic pipe of the façade
